



REDEMPTION TABERNACLE XL BY-LAWS

ARTICLE I – NAME

The Name of this Tabernacle shall be Redemption and its jurisdiction shall be the state of Idaho.

ARTICLE II – CUSTODY OF CHARTER

The Registrar shall have custody of the Charter.

ARTICLE III – INGATHERINGS

There shall be Regular Ingatherings of this Tabernacle each year, one of which shall be the Annual Ingathering to be held in the month of December, remembering that it should be near the 12th day of the 12th month. Special Ingatherings may be called by the Preceptor.

ARTICLE IV – OFFICERS

The elected officers of this Tabernacle shall be the Preceptor, Deputy Preceptor, Registrar and Treasurer, and shall be elected at the Annual Ingathering. The offices of the Registrar and Treasurer may be jointly held. The appointed officers shall be the Seven Pillars, Inner Guard and Outer Guard. All officers shall be installed at the Annual Ingathering or as soon thereafter as practicable.

ARTICLE V – MEMBERSHIP

Members shall consist of Past Commanders proposed by any Knight Priest of this Tabernacle, and shall be limited to thirty-three in number. Such proposal shall receive a clear ballot at any Ingathering before an invitation is extended. Membership shall be predicated upon membership in good standing in a Commandery or Preceptory of Knights Templar.

ARTICLE VI – FEES AND DUES

The fee for investiture in this Tabernacle shall be \$50.00, plus annual dues for the year. The annual dues for each Knight Priest shall be \$15.00 plus the annual assessment of the Grand College of America.

ARTICLE VII – AMENDMENTS

These By-Laws may be amended or repealed by a two-thirds vote of the Knights Priests at any Ingathering of the Tabernacle, provided the Registrar has notified the Knights Priests of the proposed change in advance. Amendments or changes will not be effective until approved by the Grand Preceptor. All changes must be submitted through the Grand Registrar in triplicate.

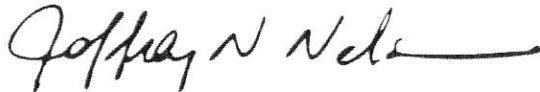
